Wellington College, Photo, Film and Audio Recording Consent Form

Images are used to publicise and promote the College as a whole or a particular aspect of College life. Often, these photos and recordings will focus on particular individuals meaning that they are clearly identifiable. The images may be included in a range of materials (including the College's prospectus, other advertising (including posters and banners) and news stories shared with third party outlets) and may be in print or online. The images will be able to be viewed throughout the world, not just in the United Kingdom, and some overseas countries may not provide the same level of protection to the rights of individuals as UK legislation.

Before using images for the purposes set out above, we will seek the consent of the individual involved or their families if they are unable to provide consent themselves. Names will not be used without your consent although descriptions may be included. Once consent has been given, it will continue indefinitely unless you notify the Deputy Head (Communications) in writing that you withdraw or amend your consent. Please be aware that we cannot withdraw images from publications already produced. Master copies of any publicity and promotional material will be held in the College's archive indefinitely.

Regarding intellectual property, we will also ask both the individual to confirm that they do not own the copyright or have any claim of ownership or other claim over the photos. Certain video and audio recordings featuring individuals taken for the purposes set out above may be a qualifying performance under the Copyright, Designs and Patents Act 1988. If so, the College will also seek the consent of the individual to edit, reproduce, distribute and make available the recording of the performance(s) to the general public in any format.
